Rules & Regulations:

- 1. Purchasers will receive their raffle ticket stubs by mail or ticket numbers by email depending on the purchase date. Checks that are returned for insufficient funds or other reasons will disqualify the ticket. Tickets will also be sold at the APIDC Gala on November 19, 2016. APIDC is not responsible for any lost, illegible or incomplete purchase forms or entries.*
- 2. Ticket price is not tax-deductible. All ticket sales are final and payments non-refundable.*
- 3. APIDC is a 501(c)(3) non-profit organization registered with the California Secretary of States. Proceeds of the raffle are solely for the benefit of APIDC.*
- 4. Participants must be 18 or older to enter the raffle and be eligible for the prize package.*
- 5. One (1) winning ticket will be selected by random drawing at the APIDC Gala, November 19, 2016 at the Cicada Restaurant, 617 South Olive Street. The winner need not be present. If not present, the winner will be notified by phone or email. The winner of the prize must claim and accept the prize by December 3, 2016, or the prize will be forfeited and a new winner will be selected.*
